Release of Liability
SARS-CoV-2 Coronavirus/COVID-19
Printable Waiver

The novel coronavirus, SARS-CoV-2, which causes the disease, COVID-19, has been declared a worldwide pandemic by the World Health Organization. SARS-CoV-2 and COVID-19 are understood to be extremely contagious. Current medical knowledge is uncertain and evolving, but holds that the SARS-CoV-2 virus can and does spread from person-to-person contact (including via those without apparent symptoms of COVID-19 or other disease) and/or by contact with contaminated surfaces, objects, and through the air. The exact methods of spread and contraction are unknown, and there is no known treatment, cure, or vaccine for COVID-19. Evidence has shown that COVID-19 can cause serious and life-threatening illness and even death.

The GREAT LAKES CRUISING CLUB (hereafter, "GLCC") cannot prevent you from becoming exposed to, contracting, or spreading COVID-19 while attending GLCC events. It is not possible to predict or prevent the presence of the disease. IF you choose to attend a GLCC event you will be potentially exposing yourself to SARS-CoV-2 and risk contracting COVID-19.
